More Snow Will Come!

This is from our Snow Removal Policy:

When will the City start Snow or Ice Control Operations?

<u>City discretion</u> will decide when to begin snow or ice control operations. The criteria for that decision are, but not limited to: snowfall of 3 inches or more, drifting, icy conditions and time of snowfall. *Note: City will also decide when to contact our snow removal contractor for help.*

City streets will be plowed within 24 hours from the end of the snowfall. Operations shall continue until all roads are passable or additional snowfall occurs. Widening and clean-up operations may continue immediately or on the following working day depending upon conditions and circumstances. Alleys will be cleaned last or as time permits. Operations may be suspended during periods of limited visibility. During the snow plowing or snow cleanup process, no vehicles shall be parked on the street. Note: Please be aware and move your vehicle to a plowed area.

Resident responsibility: Property owners shall remove snow from around fire hydrants near their property. The hydrants need to be cleared in order for use of the hydrants by proper emergency personal. Residents are not allowed to place snow on public roadways or sidewalks. This is in accordance with Minnesota State Statutes.

Sump Pump Waivers:

Do you have a sump pump? If you do not need to utilize a waiver described below, you do not need to do anything. BUT, if you need to discharge your sump pump into the drain at any time from November 1, 2018 to April 1, 2019, you MUST apply for a waiver. They are available at the office or find it on our city website! Return your waiver form along with the \$25 fee to the city office and it will be approved the next council meeting.

Trimming of Trees:

Code 90.01: Trees and shrubs in the boulevard areas are property owner's responsibility, not the City's. All trees shall be pruned to sufficient height to allow free passage to pedestrians and vehicular traffic; nine feet over sidewalks and pathways and 13 feet over streets, pathways and alleyways. **Note:** The proper trimmed height helps to make garbage collections and snow plowing safer.

Compost Site:

The compost site is closed for the season.

11/12/2018- Council Briefs

Consent Agenda:

Council approved the consent agenda which included: bills totaling \$62,782.09, twelve sump pump waivers, Resolution 2018-10 designating the 2019 polling place, and a 3-year agreement with Lafayette Excavating for snow removal.

Reports:

Fox – Fox updated council on the water filter repair. LMC Insurance Trust approved the engineers plan and their recommended option to repair the filter for a cost of \$176,800.

Burger – Due to election results once mayor-elect Sandberg is sworn into office in January, council can then declare a vacancy for the remainder of Sandberg's term ending in 2020. The 2019 council will be the ones to fill the vacancy by appointment. Ditch assessments are based on a percent of the repair work needed in any ditch in which the water of the city may flow through.

Council action:

Approved the purchase price \$30,000 and moving forward with the building exchange with Isenberg Electric, by a 2-1 vote, Sandberg and Reed approving and Portner against, adopted Resolution 2018-09 - Canvass of the 2018 Election Results, adopting Resolution 2018-08 approving membership in the Minnesota Environmental Science and Economic Review Board (MESERB), approved the first reading of Ord. 127 – Enacting and Adopting Supplements to the code of ordinances, denied a request by A. Platz to permanently remove a street light, and requested he have his tree work done by January 1, Fox will contact Xcel to reinstall the light after that date.

Discussion:

Discussed sample ordinances of cargo/storage containers in residential areas.

On Monday, December 10, 2018, council will hold the 2nd Truth in Taxation hearing and the regular council meeting. All council meetings are held in the city building's council chambers at 700 9th Street at 7 pm., and are open to the public.
