# **A Few Reminders:**

Foul play: This pops up every once in a while, chickens and other farm animals are not allowed in the city. There are some cities who have passed ordinances to allow chickens, with specific regulations as to how many hens, no roosters, enclosed coops, and an annual permit fee. No one has approached the city council to ask for a similar chicken ordinance to be drafted for our city.

ATVs, etc.: There have been concerns of underaged children driving ATVs, etc. These types of vehicles, although the city does not currently have an ordinance of this nature, must still abide by the State law pertaining to age limits, where

equipment it must have, etc. A recent concern was that a small ATV type vehicle was driven **inside** the kiddie park – no motorized vehicles are allowed for the safety of the children playing there. If you see something speak up. **Kiddie Park Fence:** The Lion's worked very hard to build a beautiful fence protecting the children using the kiddie park - do not allow children to climb on it. Again, if you see something, speak up. It takes the community to keep everyone safe!

#### **Council Briefs:**

Workshop: Council met on August 23, for a personnel policy workshop, they started the process at a work session in May. Some items that were discussed & added: bereavement pay, call back, return to work after illness, jury duty, leave for an employee on the fire or ambulance crew leaving for a call during hours, a social media policy & public notice, updating performance reviews, year-end PTO, working on a holiday pay, when benefits start, and who sits on the personnel committee. The final review for approval is on 9/12/2022.

# 9/12/2022 Council meeting:

Approved **Resolution 2022-18** A Resolution Withdrawing a Rezone Application; thus, cancelling the need for the public hearing.

**Public Hearing for Interim Ord. 139,** City attorney Walton explained the need for the criteria as a guide for council's zoning decisions. The Interim Ordinance is good for one year. Council approved it as an agenda item later in the meeting.

**Approved the consent agenda:** Included in the consent agenda were: 8/8/2022 council minutes, 8/15 Special meeting & Budget workshop minutes, the 8/23 Personnel Policy workshop recap and bills totaling \$47,604.55

**Guests:** Doug Hanson – Winthrop Publications, Adam Prochniak – AP Lawn Service, Patti Jo Ferguson – 711 Laf. Ave., Mac Aalid – 660 Esther Ave., Tristan and Amanda Blue – 1160 Main Ave., and Marj Hurd – 680 Esther Ave.

**Citizen concerns:** Aalid and Ferguson reiterated their concerns of the property at 691 Lafayette Avenue; in August council removed it off the blight list as the issues were satisfied.

#### **Council Briefs continued:**

Unfinished Business: RO Water Project: No scoring back from the health department, but it sounds like it will be a good score. The drawback is that the state has not passed a bonding bill, the federal funds sit there. Blight Properties: 400 Wanser was served orders on August 18, 2022 with 15 days to comply, that time has passed and Walton will file with the court on Tuesday, September 13, 2022. Approved: Job descriptions for the Pay Equity review, personnel policy as amended, to proceed with the mini park ramp, bandstand steel updates and first sidewalk, and to have the cleaning service come twice a year. Denied: Bid for Chevy truck that came in under the minimum set.

New Business: Approved: Zoning Permit LAF 2022-11 for a garden shed. A public hearing for Permit - LAF 2022-12 Zoning Application for a variance for a porch to be built within the 25-foot setback was set for the October 10<sup>th</sup> council meeting. Discussion of an inquiry for an extended driveway up to the property line. Per city attorney a variance application would need to be submitted and follow the process of such. September donations of \$22,977.00 were approved and included: \$250.00 L. Drogemuller to the Fire Department, NU KNUJ Fast Pitch \$80.00 for the use of the ballfield, Southern MN Initiative Foundation a \$10,000 grant for materials for the ramp and bandstand update, St Gregory Church Board \$7,500 and \$5,000 to the ramp and bandstand project & Ambulance, Bruce & Rosemarie White \$100.00 to the Ambulance and Fillmeup \$47.00 from a donation bucket for the ramp project. Approved the 2023 Preliminary Property Tax Levy with a preliminary increase of \$41,111. Building Code: Tauber brought up a conversation of the city adopting the State Building Code. Peterson asked if New Ulm's Ellwood Zabel would come to a meeting to answer questions. Fire Training: Nick inquired about training policy for the city paying for one fire member to go to conference. Mowing: Adam Prochniak thanked council for the contract for the 2022 season, he understands council is considering mowing inhouse. He pointed out some items for council to consider before they reach that decision; cost of equipment as a new commercial mower is \$16,000 to \$18,000, liability insurance, State is looking to eliminate gas powered engines in the future and such. He is adding another mower and updating his spraying equipment and asked when deciding whether or not do in-house or contract if, could be earlier in the year. Quasquicentennial: Mayor would like everyone to start thinking of this celebration. Parking: Portner brought up a concern on long-term parking on the street. Mayor explained as long as it had current license tab and operable, there is no time restriction. There is a code for recreation vehicles of 48-hour limit, and the winter parking code that runs from November 15 to April 30. MPCA Small Communities Planning Grant: The utilities committee met on August 29, 2022 to discuss the grant and possible project for the City. The scope of the project would be to identify the condition and material type in the wastewater collection system to include sanitary sewer mains and sanitary service lines. It would involve cleaning all sanitary sewer mains and televise the sewer mains and service lateral lines, and receive a detailed report to include a video of the televising, which would be city property for future needs. This information will give the city information to formalize an I/I reduction strategy. Having this information could help with future opportunities with grant funds, further reduce needs for sanitary sewer overflows, basement backups and flooding. The city would be responsible for 10% of the cost of the project in matching funds, with in-kind services allowed to offset some of the matching funds. Council approved up to \$10,000 matching funds.

Special Meeting Monday, September 19: On 9/12/2022 Mayor Peterson called a special meeting after she and Fox met via Zoom with the SEH engineers about the MPCA grant application. After they reviewed the scope of the project, they felt a grant application that had a stormwater element tied with the current sewer and sewer lateral inspection project scope would have a better chance of being selected/ awarded. The city's responsibility of 10% was capped at \$10,000 at the September 12, 2022 council meeting; adding the stormwater element would increase the amount needed. Council approved up to \$15,000 to cover the matching funds.
