Motioned by Reed and seconded Tauber by to approve the Consent Agenda as presented; all ayes, motion carried. Included in the consent agenda were: 5/5/2022 minutes and Personnel Policy Workshop recap and bills totaling \$61,733.54

<u>Resident Concerns:</u> JoAnn Bieraugel was on hand to share her concern of the truck traffic of farm and manure hauling from the private farm road through the city streets at all times of the day and night. Her concern is the wear and tear on the streets and safety of residents. Mack Aalid shared concerns of a property in his neighborhood, Patti-Jo Ferguson shared concerns of a property in her neighborhood.

Reports:

Fox: recapped the submitted report; new truck is here and he is meeting tomorrow for a quote for the wing assembly. MDE started a statewide PFAS monitoring project, it is volunteer and he recommends participating. **Burger:** Shared the assessor's recommendation to the two properties council motioned for them to review and take to the County Commissioner's LBAE 471 Lafayette Avenue dropped from \$169,900 to !\$133,300 and 580 11th Street from \$18, 700 to \$99,700. She will be working on the 2023 budget and ask for all to think of items that need to be discussed for the next year.

Portner: Fire Department held a house burn training last week. There were 9 new firefighters from the surrounding area who participated.

Unfinished Business:

RO Water Project: We could hear if the Congressionally Direct Spending Request is approved or not by early July, the Intended Use Plan was submitted 6/3 and draft IUP is open for comment in early September. Plan and Specification submission and the Loan application to Public Facilities Authority (PFA) is 6 months after the IUP is finalized, approximately March 2023.

Personnel Policy: Reviewed updates, will continue to look into a few areas of concern.

Reconveyed Property: County approved the reconveyance and applied for a Conditional Use for the City park.

Social Media: Motioned by Portner and seconded by Polich to approve the City of Lafayette Social Media Public Notice as presented; all ayes, motion carried.

Travel & Training Policy: Motioned by Polich and seconded by Portner to approve the City of Lafayette Social Media Public Notice as amended; all ayes, motion carried.

Credit Card: Motioned by Reed and seconded by Portner approve Resolution 2022-10 - Authorizing Opening a City of Lafayette Credit Card, as amended; all ayes, motion carried.

Credit Card: Motioned by Portner and seconded by Polich approve Resolution 2022-11 – Approving Official Signatories for the City of Lafayette Credit Business Credit Card as amended; all ayes, motion carried.

Credit Card: Motioned by Polich and seconded by Tauber approve the City of Lafayette Credit Card Policy as amended; all ayes, motion carried.

Credit Card: Motioned by Tauber and seconded by Reed to approve The City of Lafayette Credit Card Use Agreement as presented; all ayes, motion carried.

Contracted Cleaning Service Quote: L&L Handyman and Cleaning Service submitted a quote after visiting the Community Center. A rough estimate of 12 hours for a deep clean for \$435 (12 X \$36.25 per hour) plus mileage for 58 miles round trip was presented. Council discussed and the consensus was that they would like to have him come once and then go from there, possible twice a year or an on-call basis. Burger will contact him.

Blight: The council reviewed the notes of the blight tour and citizen concerns. Peterson commented that she thought the city overall looked much better this year, with a few major issues. Letters will be sent for grass/weeds and vehicle violations and also for the more detailed trouble properties. Peterson shared that the council updated its abatement ordinance and also contracted with the county attorney's office, if needed for further action.

FYI: Peterson mentioned the Mini Park committee cancelled its June 8th meeting due to the fact the Legion was still working on getting information on the veteran's paver area around the flag pole.
